University Fee: University Fee (Enrolment and Examination Fee/ Student Welfare and Development Fee/ e- Resource Consortium Charges Fee) will be deposited by each student separately as per the instructions of AKTU, Lucknow. Students may note that Fees deposited at

the time of counseling, as the case may be, i.e., Rs. 20,000/- or Rs. 12,000/- will be adjusted in the total fees deposited. For example, if a student has to submitted Rs. 20,000/- at the time of counselling then Boy has to bring a Demand Draft of Rs. (57,300 - 20,000) i.e., Rs 37,300/- at the time of admission & Girl have to bring a Demand Draft of Rs. (68,300 - 20,000) i.e., Rs 48,300/- at the time of admission Similarly, if student has submitted Rs. 12,000/- at the time of counselling then Boy has to bring a Demand Draft of Rs. (57,300-12,000) i.e., Rs 45,300/- at the time of admission & Girl have to bring a Demand Draft of Rs. (68,300-12,000) i.e., Rs 56,300/-at the time of admission.
